#### **Objective:**

The consultancy involves facilitating, coordinating, and reporting on Para sports activities for CBM India Trust, ensuring that all information shared with management is accurate, timely, and aligned with the organisation's mission, statutory requirements, and internal guidelines. The consultant will support CBM India's Para sports programme by providing strategic guidance, ensuring regulatory compliance, coordinating with stakeholders, and empowering para-athletes, contributing to the overall success of inclusive sports development.

## **Responsibilities:**

- Coordinate closely with para-athletes to support their training, competition participation, and career growth.
- Assist athletes with documentation, classification, and compliance with sports regulations.
- Maintain updated athlete profiles and track progress against defined goals and milestones.
- Plan and monitor project activities in alignment with CBM India's inclusive sports strategy.
- Prepare and submit timely project reports, updates, and documentation (monthly/quarterly/annual).
- Work collaboratively with the Lead, Programme and other teams to ensure the timely completion of activities.
- Liaise with sports federations (PCI), government bodies, and sports organisations for programme impact.
- Support athlete promotion through digital presence, media engagement, and community visibility.



- Coordinate with coaches, physiotherapists, and other support professionals as required.
- Travel to field locations to assess programme implementation and provide athlete support and make insights.

## **Qualifications and Experience:**

- Graduate with a minimum of 3 to 4 years of experience in para-sports or related fields with NGOs or para-sports institutions.
- Strong understanding of para-athlete classification, training coordination, tournament participation and regulatory processes.
- Experience in working with para-athletes, coaches, and federations, etc.
- Access audits (physical spaces and digital accessibility), will be an advantage.

- Knowledge of inclusive sports and disability-specific needs.
- Strong programme planning, coordination, and communication skills.
- Proficiency in programme documentation, assessment, and reporting.
- Outreach knowledge and athlete promotion/growth capabilities.

- Ability to travel when required and adapt to dynamic program requirements.
